


ORDER:

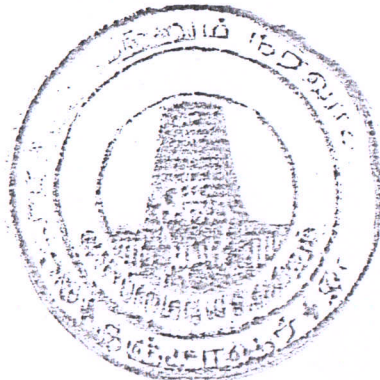

Under the Provisions of the Sub Section (1) of Section 6 of the Tamilnadu Public Buildings (Licensing) Act, 1965, Public Building Licence (Renewal) is hereby granted to **Maharishi Vidyamandir School, Ward No.4, Block No.59, T.S.No.3044, TPS Nagar, 7<sup>th</sup> cross, Medical College road, Thanjavur** in respect of the building situated in the above mentioned address subject to the following terms and conditions and for the period mentioned hereunder.

1. The period of validity of the renewed Public Building Licence sanctioned shall be from **13.06.2023 to 31.05.2026** (inclusive of both days.)
2. There should be no additions or alteration in the existing building for which this license is herewith granted in future without getting prior permission from the competent authority. A fresh licence has to be obtained from the competent authority if any addition or alteration is proposed to be made to the existing building or a portion of building, for which this license has been granted. This License is issued to the building for running school purpose only.
3. A Licence shall be renewed from time to time based on the application along with required supporting documents with the competent authority well in advance before the date of expiry of the existing license preferably not less than 2 months before the date of validity of the existing licence .
4. This licence is liable to be suspended for any violation of the Act or Rules framed thereunder or the conditions of this licence or if the licensed premises are not found conforming to the description shown in the attached plans and Annexures.




